- Create communication tools that are helpful for different ministry areas that educate and offer encouragement to our commissioned workers across the district.
- Get to all EEC programs and Schools in the District to build relationships- lead chapel if possible. Determine what they feel would be most helpful from the district.

- G2G- Develop a full understanding of the research and history within the MDS. Work with other District Leadership to develop the new direction for G2G in the District.
- NLSA-

  - Continue working with Belvoir Christian Academy Preschool, Chattanooga TN, to complete the NLSA Process Spring 2025.
  - Train schools on Protocol G, New EEC Protocol, and Micro-School Protocol. Train schools in area of Strategic Planning. Look at possibility of increasing the number of EEC/Preschools accredited by NLSA. Maintain State partnerships in AR, TN, and KY with NLSA.
- Supervise (University Field Supervisor) 4 Student teachers in Memphis Oct-Dec 2024. (2 at CTK and 2 at ILS)
- Participate in conferences and training sessions to enhance knowledge and build connections throughout the Mid-South and Synod, in consultation with President Paavola.
- Provide School Board Training and Lead Chapel in Schools and EEC Programs across the Mid-South, Spring 2025 as requested and/or invited.

## **NLSA Update**

NLSA is seeing extensive changes in the next year. NLSA was just approved to be a member of the National council for Private School Accreditation (NCPSA). This partnership will strengthen NLSA's influence and ability to be recognized by State Education agencies. This is important in light of so many states voting voucher into existence. New protocols in Elementary and EEC are being rolled out. Schools will be expected to have a comprehensive Strategic Plan and an external financial review. Most of our schools do not have regular external financial reviews, this new expectation will be a challenge for some of our schools. However the data has shown financial stability is critical for long term sustainability in our Schools.
