Resolution 03-02-21

SUBJECT: To Increase the Awareness of Human Trafficking to the Congregations of the Mid-South District and The Lutheran Church—Missouri Synod

(Reference Overture 03-03-21 printed on page 161 of Convention Workbook)

WHEREAS, Human Trafficking, including forced labor and sex trafficking, affects an

estimated 24.9 million victims worldwide at any given time (US Dept of State)¹

and

WHEREAS, The Office of National Mission² and Lutherans For Life³ have addressed human

trafficking (see footnoted resources); and

WHEREAS, Many people in LCMS congregations are unaware of the magnitude of this

deplorable act against humanity; and

WHEREAS, God created all life and sent His Son Jesus to redeem all life, and He desires that

all people come to the knowledge of Him and be saved (I Timothy 2:4), and He desires all to have abundant life in Him (John 10:10) and He has commanded us to love our neighbor as ourself (Matthew 19:19, Mark 12:31, Luke 10:29ff);

therefore be it.

RESOLVED, That the Mid-South District in convention establish a Human Trafficking Task

Force, as soon as possible, to study this inhumane activity with-in the boundaries of the Mid-South District, while working with Federal, State, and Local agencies,

and to provide a report back to the next District Convention; and be it further

RESOLVED, That the Mid-South District Task Force on Human Trafficking make readily and

widely available to the congregations of the Mid-South District, documents and resources to increase the awareness of Human Trafficking, to include directives

to follow should Human Trafficking situations be observed; and be it further

RESOLVED, That the Mid-South District in convention memorialize the Synod in Convention

to update the resources provided; and to also direct the CTCR to produce a

document addressing Human Trafficking; and be it finally

RESOLVED, That the Mid-South District in convention rise to pray that Almighty God would

by His power bless and direct all law enforcement agencies in their fight against

Human Trafficking and that He would through His Church and other relief

Resolution 03-03-21

SUBJECT: To Protect Christian Consciences

(Reference Overture 03-08-21 printed on page 169 of Convention Workbook)

WHEREAS, Christians are called to "render to God what is God's" (Luke 20:25) and to "obey

God rather than man" (Acts 5:29); and

WHEREAS, Christians are called to "obey their magistrates save when they are commanded

to sin" (Ap XVI: 6-7); and

WHEREAS, The Holy Scriptures teach that man is not free to bind the conscience of another

to a merely human commandment (Galatians 5:1-6; Romans 14); and

WHEREAS, There are increased attacks on Christian conscience; such attacks including but

not limited to attacking Biblical authority regarding the sanctity of human life, human sexuality, Christian marriage, necessity of in-person Christian worship,

and other issues of Christian conscience; and

WHEREAS, This is clearly evidenced not only anecdotally, but also concretely, for instance,

by the recent Equality Act in the U.S. Congress (H.R. 5), negating application of The Religious Freedom Restoration Act of 1993 (see Sec. 1107), and redefining

sex beyond the Biblical teaching (see Sec. 1101); and

WHEREAS, This violation of conscience is a violation of one's Christian freedom and

Christian wisdom and may result in sin; and

WHEREAS, There is historic success in claiming religious exemption from violations of

conscience on the basis of Religious Freedom in America (e.g. Philadelphia v. Catholic Social Services (2021) or Lutheran Church-Missouri Synod v. FCC

(1988) or Meyer v. Nebraska, (1923)); therefore be it

RESOLVED, That the LCMS Mid-South District, congregations and their members abstain

from every teaching of men that violates their Christian conscience which is

bound to God's Word alone in every sphere of life; and be it finally

RESOLVED, That the LCMS Mid-South District, give its full support and assistance of every

kind to any congregation of the District or member of a District congregation in securing religious exemption from teachings and practices contrary to God's

Word.

Resolution 03-04-21

SUBJECT: TO REJECT RACISM AND ADVANCE THE GOSPEL

(Reference Overture(s) 03-01-21, 03-02-21, 03-04-21, 03-06-21, 03-07-21, Late Overture 03-09-21 printed on page 157-158, 159-160, 162-163, 165-166, 167-168 of Convention Workbook)

WHEREAS, God has created all people and they are blood related going back to our mutual fathers, Adam and Noah, and all are subject to the stain of original sin, but now also have been equally redeemed by the blood of Christ in order to be reconciled to God and to each other; and

WHEREAS, God's Word says, "If you really fulfill the royal law according to the Scripture, "You shall love your neighbor as yourself," you are doing well. But if you show partiality, you are committing sin and are convicted by the law as transgressors." (James 2:8, 9); and

WHEREAS, Racism (the sinful notion that some races are inherently superior to others), misunderstanding, and strife are present in the world and in the Church; and

WHEREAS, The Lutheran Church—Missouri Synod (LCMS) abhors racism, and in convention has passed resolutions repudiating all racism, (see 1992 Res. 3-03 and 2019 Res. 11-04A); and

WHEREAS, Critical Race Theory (CRT) has become a common, multifaceted, and controversial theory for discussion of contemporary race relations; therefore be it

RESOLVED, That the Mid-South District in convention reject the world view of CRT where it is contrary to Scripture and counterproductive to true racial conversation and reconciliation, and also reject all organizations, movements, petitions, and theological language that support that world view in a positive manner; and be it further

RESOLVED, That the LCMS Mid-South District reject any doctrine that teaches:

- One's race, ancestry, or nationality are inherently superior to the race, ancestry, or nationality of another.
- Any individual is inherently racist, or oppressive, whether consciously or unconsciously, because of his or her race, ancestry, or nationality; and be it further

RESOLVED, That the circuits of the Mid-South District of the LCMS develop an objective mission and ministry action plan for outreach to diverse communities among us; and be it further

RESOLVED,	That the congregations of the LCMS Mid-South District be encouraged to conduct conversations on race and diversity, to strengthen unity within the congregation; and be it further
RESOLVED,	That the congregations of the LCMS Mid-South District be encouraged to engage members of their communities in these conversations, in light of Christ's Gospel; and be it further
RESOLVED,	We commend those within the LCMS Mid-South District who intentionally proclaim and work to reach out with the Gospel of Jesus to those who are different from themselves in the light of the Great Commission; and be it finally

RESOLVED, That the Mid-South District send this resolution to the Synod as it gathers at its 2023 Convention to do similarly.
